**Related Filings:** This request is supplemental to and independent of prior requests concerning BSO Training Center wellness amenity change orders and Sheriff branding expenditures.

Pursuant to Florida Statute §119.07, I request the following records in electronic format.

This request concerns the staffing, classification, compensation, and actual duties of personnel assigned to fitness, personal training, sparring, or related physical conditioning functions at the BSO Research, Development, and Training Center, with particular focus on any positions whose primary or exclusive function involved providing personal training or physical conditioning services to Sheriff Gregory Tony.

**Records Requested**

Please produce records sufficient to show:

1. The job title, position classification, pay grade, and full compensation — including salary, benefits, overtime, and any supplemental pay — for all personnel assigned to fitness, personal training, sparring, or physical conditioning functions at the BSO Training Center from January 1, 2023 to the present.
2. The official job description and duty statement for each such position, including the date the position was created, the stated qualifications required, and the name and title of the BSO official who authorized creation of the position.

3. Hiring and selection records for each such position, including any job posting, applicant pool documentation, interview records, and the identity of the selecting official.
4. Time and attendance records, duty logs, or assignment records for each such position sufficient to show actual functions performed, including the dates, times, duration, and nature of activities documented.
5. Any records showing the frequency, duration, and participants in one-on-one training, sparring, or physical conditioning sessions conducted at the BSO Training Center in which Sheriff Tony participated.
6. Any contract, personal services agreement, or memorandum of understanding under which a personal trainer, sparring partner, fitness coach, or physical conditioning specialist was retained by BSO on a vendor or contract basis rather than as a classified employee, including total compensation paid.
7. Any communications — including emails, texts, or memoranda — discussing the creation, continuation, duties, or value of any personal training or sparring position at the Training Center.
8. Any organizational chart placing fitness or personal training personnel within BSO's command structure, and any records showing to whom such personnel reported.
9. Any BSO video productions, promotional materials, social media content, or public communications in which Training Center fitness or personal training staff appeared, along with records showing whether their participation was within their documented scope of duties.

*If no records exist for any category above, please confirm in writing that no such records were created or maintained. The absence of duty documentation for a compensated position is itself a finding.*

If any portion of this request is denied or redacted, please identify the specific statutory exemption relied upon and provide all reasonably segregable portions of responsive records.
